

Beginners League 2025 - Schedule of Games

10 teams entered the Beginners League Australian Pairs Competition. The fixtures have been arranged for each team to play all the opposing teams, i.e. 9 matches per team. The fixtures have been arranged around players availability on a Monday evening and the rinks pre-booked in the diary. **It may be necessary to rearrange matches at short notice to accommodate tournament matches.** All matches must be played before the green closes in September 2025.

Each team may use one substitute player who must not be a member of any other team entered in this competition. The substitute player must be a member of Woburn Sands Bowls Club with 3 years or less playing experience. A substitute may play as a substitute for more than one team.

If both team members are not available to play on the pre-booked date, then please rearrange the fixture. Consult the rink diary for availability of a rink, book the time and date of the rearranged match and please **ask Paul Hamer to cancel the pre-arranged booking.**

Australian pairs: Take turns leading, the Leads each bowl two woods, then all change ends and the partners bowl four woods each, then change ends again and bowl the last two woods. Toss for Jack, one trial end using all four woods (removing the woods from the head). 15 ends of play. If the match is interrupted, for example due to inclement weather, at least 10 ends must be played to constitute a match. If a match is continued at a later date, then the previous score is carried forward. All players require chalk and a measure. First named team will keep the scorecard and at the end of the match place the scorecard in the envelope which is pinned to the notice board and send the result by email or text to Paul Hamer. 3 points for a win, 2 for a draw & 1 for a loss.

League results and table will be posted on the notice board and the website at regular intervals.
